## ELIGIBILITY CONDITIONS

### For B.Com. Single Major Single Minor Programs

**Major: Accounting & Finance**

**Minor: Business Management**

**Condition 1:** The applicant should pass at least four (04) subjects, including English and the relevant subject\* as compulsory subjects, in 10+2 Examination held by W.B.C.H.S.E or any other board recognized by the University as equivalent thereto.

**AND**

**Condition 2(a):** The applicant should obtain at least 55% marks (Total) in the four (04) subjects as mentioned in Condition 1 above.

**OR**

**Condition 2(b):** The applicant should obtain at least 50% marks (Total) in the four (04) subjects as mentioned in Condition 1 above AND at least 60% marks in the relevant subject.

- **Note 1:** In the matter of eligibility, the percentage of marks [as mentioned in Condition 2(a) and Condition 2(b) above] up to 54.5, 49.5, and 59.5 should be rounded up as 55, 50 and 60 respectively.
- **Note 2:** All the conditions of minimum marks as mentioned in Condition 2(a), Condition 2(b) and Note 1 above should be reduced by 5 percentage points in case of applicants belonging to SC/ ST/ OBC-A/ OBC-B/ PWD category.
- **Note 3:**

(i) **Accountancy/ Accounts/Costing & Taxation** should be considered as the relevant subject in case of Major in Accounting & Finance.

(ii) Mathematics should be the relevant subject in case of an applicant passing 10+2 examination with Science subjects.

(iii) If the applicant has more than one relevant subject in 10 + 2 examination, that subject should be considered as the relevant subject in which he/ she obtains higher marks.

- **Note 4:** Applicants who pass 10+2 examination in Vocational Stream are NOT eligible to apply.
- **Note 5:** Continuing Candidates (CC) of any Boards are not eligible to apply.

## ELIGIBILITY CONDITIONS

### For B.Com. Single Major Single Minor Programs

**Major: Business Management**

**Minor: Accounting & Finance**

**Condition 1:** The applicant should pass at least four (04) subjects, including English and the relevant subject\* as compulsory subjects, in 10+2 Examination held by W.B.C.H.S.E or any other board recognized by the University as equivalent thereto.

**AND**

**Condition 2(a):** The applicant should obtain at least 55% marks (Total) in the four (04) subjects as mentioned in Condition 1 above.

**OR**

**Condition 2(b):** The applicant should obtain at least 50% marks (Total) in the four (04) subjects as mentioned in Condition 1 above AND at least 60% marks in the relevant subject.

- **Note 1:** In the matter of eligibility, the percentage of marks [as mentioned in Condition 2(a) and Condition 2(b) above] up to 54.5, 49.5, and 59.5 should be rounded up as 55, 50 and 60 respectively.
- **Note 2:** All the conditions of minimum marks as mentioned in Condition 2(a), Condition 2(b) and Note 1 above should be reduced by 5 percentage points in case of applicants belonging to SC/ ST/ OBC-A/ OBC-B/ PWD category.
- **Note 3:**

(i) **Business Studies/ Commerce/ Business Organization/Management** should be considered as the relevant subject in case of Major in Business Management.

(ii) Mathematics should be the relevant subject in case of an applicant passing 10+2 examination with science subjects.

(iii) If the applicant has more than one relevant subject in 10 + 2 examination, that subject should be considered as the relevant subject in which he/ she obtains higher marks.

- **Note 4:** Applicants who pass 10+2 examination in Vocational Stream are NOT eligible to apply.
- **Note 5:** Continuing Candidates (CC) of any Boards are not eligible to apply.
